

## **Looking for Ways to Maximize Your End of Year Gifts?**

Thinking of making a taxdeductible gift to the Priests of the Sacred Heart at year end? Here's how to get the most from your

charitable giving:

Matching Gifts - Did you know that your gift of \$50 can be matched with an additional \$50 or whatever amount your gift is? Many companies have a "Matching Gift" program to encourage charitable giving by matching what their current or sometimes former employees contribute. Check today with your employer to see if your gift can be matched!

#### **Donor Advised Funds or DAF**

- A DAF allows donors to make a charitable contribution, receive an immediate tax benefit and then recommend grants from the fund over time. Your advisor or bank can direct you to a program that would work for you.
- **Cash Donations** You may reduce or eliminate income tax up to 50% of your adjusted gross income. Larger gifts can also result in tax savings for the year the gift is made and as many as five future years!
- **Gifts of Assets** If you have owned property such as stock for longer than 1 year, you can make a gift of that asset and deduct the full current value while avoiding capital gains tax by giving this gift to a charity such as the Priests of the Sacred Heart. You may reduce or eliminate income tax up to 30% of your adjusted gross income and may be eligible for tax savings

for the year the gift is made and as many as three future years. While assets that have increased in value are your best bet in giving to charity, there are options for assets that have decreased in value.

## **Example:**

Stock gift example: Linda and Bruce are making their list of charities for year-end gifts and have decided that they will make gifts of stock that have increased in value that they have owned for a number of vears.

If they sell the stock, Linda and Bruce would be taxed on the capital gain due to the increase in value. However, because they have owned the stock for more than 1 year and are making this gift to the Priests of the Sacred Heart, they will receive a charitable deduction for the full value and will bypass the capital gain.

<u>Cash gift example</u>: Cheryl has decided that she would like to make a gift of \$1,000 this year to the Priests of the Sacred Heart. Cheryl is in the 33% tax bracket and making this gift can save her up to \$330 in taxes that would otherwise be due. If she pays state income tax in addition to Federal, her savings may be even greater.

Remember to make your gifts before December 31, 2015 to qualify for tax savings this year!

While we would be happy to discuss these options with you, we suggest you ask your financial advisor or attorney when making financial decisions.

#### **Devotion in Action!**

Every day I hear from such devoted and loving people that not only touch my heart but fill it with so much joy!

One donor recently shared with me that in her instructions for her funeral, the 30 Sacred Heart pins she purchased should be given to each of her family members to wear as well as one to be placed on her burial dress, and that any donations



for Masses on her behalf be sent to the Priests of the Sacred Heart.

#### Faith Heals All

In 1999 Susan was at her job when hot oil severely burned her hands and feet. She was told that she would never walk again. In 2000 Susan received a Sacred Heart medal and wore if faithfully each day promising to spread devotion to the Sacred Heart. Today, Susan believes that her ability to walk is her reward by the grace of God. "Faith heals all, and for all whom believe" states Susan. "I carry two medals with me all of the time so that I can share the love of His Sacred Heart. I have given out at least 50 medals to those who suffer in hopes that they too will know His love".

#### Plane tickets for volunteer hours

Cathy, a long-time volunteer with the English as a Second Language (ESL) program at Sacred Heart Seminary and School of Theology, as well as with

the Province Development Office, also works for Southwest Airlines. The airline has a program in which their employees can earn free



plane tickets for their charity of choice by racking up volunteer hours.

After counting up the many hours she had donated to ESL and the Development Office Cathy realized that she earned six Southwest Airlines tickets. Her charities of choice? The same ones at which she devoted her volunteer hours: SHSST and the Province Development Office.




## Pilgrimage to Ireland - September 2016
